[07:40] Takagi

Yeah.

[07:42] Takagi

Usui Eiichi-san, who lives here in Midoridai.

[07:45] Takagi

We even checked his drivers license.

[07:48] Haibara

Then why did he lie about being Kanieda from Shikabone City?

There's that, too.

[07:54] Conan

Detective Takagi, why did the police pick him up?

[08:00] Takagi

He's a person of interest in an injury case.

[08:03] All

What?

[08:04] Takagi

Just now, behind Midoridai Park, a woman who lives nearby found a man

who'd been struck on the back of the head with a log.

[08:14] Takagi

The victim is Hachiya Takeru-san from Midoridai.

[08:18] Hachiya

Damn it.

SIGN Hachiya Takeru (45)

[08:19] Hachiya

I don't know who it was, but they suddenly hit me from behind.

[08:22] Hachiya

Quick slacking off, officers!

[08:25] Hachiya

Go find the culprit and bring him to me!

[08:29] Takagi

According to his neighbors,
he's not a very nice person.

[08:34] Megure

*The man got into a rather
fierce argument with Hachiya?*

SIGN Kakimoto Sueko (28)

[08:39] Sueko

Several days earlier, outside the station.

[08:42] Sueko

I'd seen the man several times before,

[08:45] Sueko

so I figured he was a resident of Midoridai.

[08:47] Chiba

Inspector.

[08:49] Chiba

We found this on the pen on the ground.

[08:52] Megure

E.U.?

[08:54] Takagi

Eiichi Usui.

[08:56] Takagi

He's the man we identified as
our primary person of interest.

[09:00] Usui

I admit I got into a fight with Hachiya
because I have a grudge against him.

[09:04] Usui

But I just lost this somewhere,
and I haven't been to the park.

[09:09] Megure

Then where were you and what were you doing
today around 1PM when Hachiya was attacked?

[09:15] Usui

W-Well, I...

[09:18] Megure

Why can't you tell us?

[09:21] Usui

I can't remember.

[09:25] Usui

I know. At exactly that time,
I experienced temporary amnesia.

[09:31] Takagi

It's probably him.

[09:34] Takagi

His lie is extremely unconvincing.

[09:37] Conan

Wait. Hachiya was attacked around 1PM today?

[09:41] Takagi

Yeah, according to Hachiya-san's testimony.

[09:45] Conan

Then he's innocent.

[09:47] Takagi

What?

[09:48] Haibara

He has an alibi.

[09:50] Mitsuhiko

He was in Beika City around that time.

[09:52] Genta

That's right.

[09:54] Ayumi

Yeah.

[09:54] Takagi

What?

[09:55] Conan

He forgot something in Beika City while he was there.

[09:59] Conan

His fingerprints should be on this.

[10:03] Megure

What? The kids saw him?

[10:05] Chiba

They're witnesses?

[10:07] Usui

Did something happen?

[10:08] Megure

Someone claims to have seen you in Beika City when the incident occurred.

N-No! I've never been to Beika City!

[10:20] Conan

What? He denied it?!

[10:23] Takagi

Yeah.

[10:24] Takagi

He said it must've been someone else.

[10:26] Conan

But...

[10:27] Forensics

Excuse me, Takagi-san.

[10:32] Takagi

I see. Thank you.

[10:36] Takagi

None of Usui-san's fingerprints
were on the lighter you turned in.

[10:42] All

What?

[10:43] Takagi

In other words, the man you saw in
Beika City wasn't Usui Eiichi-san,

[11:09] Conan

There really is a Kanieda
from Shikabone City.

What?

SIGN Kanieda Akira

[11:14] Haibara

Looks like there's only one.

[11:16] Conan

Kanieda Akira...

[11:19] Conan

If we check out this person,

[11:22] Conan

we may be able to figure out why Usui
Eiichi is behaving so mysteriously.

SIGN Current Time

SIGN Destination

SIGN Sawabukuro

SIGN Local Express

[11:33] Sign

Stops At Every Station

[11:33] Genta

Hey, all ones again today.

[11:36] Genta

I really am lucky.

[11:38] Conan

Hey, hurry up. Let's go.

[11:40] Mitsuhiko

Coming.

[11:42] Genta

Huh? They're leaving. Hey, wait.

[11:44] Sign

Kanieda Stamps and Seals

[11:45] Conan

What? Your neighbor Kanieda
Akira-san is in the hospital?

[11:49] Tone

Yeah, apparently he was hit by a car
yesterday afternoon on the other side of the station.

[11:55] Conan

A traffic accident...

[11:57] Tone

If you kids have business with
Akira-kun, why don't you come with me?

[12:00] Conan

Would that be all right?

[12:02] Tone

I was just on my way to visit him.

[12:05] Sign

Shikabone City General Hospital

[12:06] Tone

According to the nurse,
he's not seriously injured,

[12:09] Tone

but he still hasn't regained consciousness.

[12:13] Tone

Excuse us, Akira-kun.

[12:15] Conan

What? This is him?

SIGN Kanieda Akira (36)

[12:17] Tone

This is Kanieda Akira-kun.

[12:20] Mitsuhiko

They look similar, don't they?

[12:22] Genta

He and that Usui guy...

[12:24] Ayumi

Look exactly alike.

[12:26] Tone

Anyway, what was he doing on the south side of the station?

[12:30] Tone

He thinks it's bad luck.

[12:32] Conan

Bad luck?

[12:34] Tone

Akira-kun's been living with his mother since his father passed away.

[12:40] Sign

Shikabone City Saruwatari Dental Care

[12:40] Tone

About a year ago, his mother had some dentures made by a well-known dentist

[12:45] Tone

named Saruwatari-sensei on the south side of the station.

SIGN Saruwatari Kanzo (40)

[12:50] Tone

But shortly afterwards, something unfortunate happened.

[12:54] Kanieda

Mom, I'm home.

[12:57] Kanieda

You'll catch a cold if you nap there.

[13:01] Kanieda

Hey, Mom.

[13:04] Kanieda

Mom?

[13:06] Kanieda

Mom! Wake up! Mom!

[13:09] Tone

She fell asleep while wearing the dentures and they got caught in her throat.

[13:14] Tone

She didn't wake up after that.

[13:18] Kanieda

It wasn't an accident!

[13:19] Kanieda

It wasn't an accident.

[13:21] Kanieda

Those dentures were poorly made.

[13:24] Kanieda

That quack Saruwatari killed my mom.

[13:27] Tone

*That's what you call unjustified
resentment, Akira-kun.*

[13:31] Kanieda

That quack killed my mom.

[13:36] Tone

Because that dentist is over there...

[13:38] Haibara

He'd consider the south side
of the station unlucky.

[13:41] Haibara

Then why did he go there?

[13:44] Conan

You said Kanieda-san's accident
happened yesterday afternoon.

[13:49] Conan

Did it happen to be around one?

[13:51] Tone

Yeah, I heard it was just after one.

[13:54] Conan

I knew it.

[13:55] Conan

That's the same time Usui-san started
wandering around Beika City.

[14:00] Genta

That's around the time we
saw all ones on the clock.

[14:03] Mitushiko

So, what about it?

[14:05] Conan

If I'm right, then...

[14:10] Conan

When Kanieda Akira-san was
transported here by ambulance,

[14:13] Conan

did he have any possessions on him?

[14:15] Nurse

Possessions?

[14:21] Mitsuhiko

What are these?

[14:23] Ayumi

Gloves and rope?

[14:25] Genta

Was he planning on doing some kind of work?

[14:29] Haibara

Could it be?

[14:30] Conan

Yeah, probably.

[14:32] Sign

Shikabone City Saruwatari Dental Care

[14:32] Sign

Hours

[14:32] Sign

Appointments Accepted

Until Noon

[14:32] Sign

Afternoon Appointments

From 14:00

[14:35] Conan

Saruwatari-sensei lives alone,

[14:37] Conan

And he apparently always eats

lunch at home next door.

[14:41] Haibara

Then like you suspected...

[14:44] Conan

Yeah, he was probably aiming for that window.

SIGN Midoridai Apartments

[14:52] Conan

I got the landlord's testimony.

[14:54] Conan

Usui-san suddenly shaved his head the day

[14:56] Conan

before yesterday even though

he'd worn it long before.

SIGN MPD Midoridai Police Station

[15:01] Megure

I don't know why, but these
children insist on seeing you.

[15:11] Usui

Uh, have we met?

[15:14] Conan

We met yesterday in Beika City.

[15:18] Takagi

You mean...

[15:19] Conan

We weren't wrong. It really was him.

[15:23] Usui

But I've never been to Beika City.

[15:26] Conan

Kanieda Akira-san asked
you to lie, didn't he?

[15:29] Conan

He wanted you to be his double
in his plot to kill the dentist.

[15:38] Megure

I see. So he was plotting a murder.

[15:41] Conan

Yes.

[15:42] Conan

It may have been unjustified,

[15:44] Conan

but Kanieda-san couldn't
forgive Saruwatari-sensei

[15:48] Conan

and attempted to avenge his mother.

[15:51] Conan

But suspicion would've fallen
on him due to his motive.

[15:55] Conan

That's when he happened to see Usui-san and
came up with a way to avoid being caught.

[16:01] Conan

He attempted to fabricate an
alibi for the time of the crime

[16:03] Conan

by using this man who looks just like him.

[16:07] Megure

So you're an accomplice to a murder plot.

[16:10] Usui

You're lying.

[16:12] Conan

You seem to be unemployed, so
you probably did it for money.

[16:17] Kanieda

I've got a way to get rich quick

[16:20] Kanieda

that only works for you.

[16:23] Kanieda

Here's your advance payment. Take it.

[16:26] Kanieda

If I'm successful, I'll pay you double.

[16:29] Kanieda

Not a bad deal, right?

[16:33] Usui

You're lying!

[16:34] Conan

Yesterday, on the day of the planned murder,

[16:37] Conan

Kanieda-san had Usui-san cut his

long hair to look like his own

[16:41] Conan

and sent far away from
Shikabone City to Beika City.

[16:45] Conan

He had him enter a café
he'd picked out beforehand

[16:48] Conan

and waited for the right
time to place a call.

[16:51] Kanieda

*There should be a man named Kanieda
from Shikabone City there.*

[16:56] Usui

Yes, that's me!

[16:58] Usui

Kanieda from Shikabone City.

[17:01] Conan

That allowed him to create
numerous witnesses for the alibi.

[17:04] Conan

Furthermore, by leaving behind
a lighter with his fingerprints,

[17:08] Conan

he had physical evidence as a backup.

[17:11] Conan

With his fake alibi secured,

[17:15] Conan

Kanieda-san headed out to
murder Saruwatari-sensei.

[17:19] Conan

That dentist accepts appointments
until noon, right?

[17:24] Sign

Shikabone City Saruwatari Dental Care

[17:24] Sign

Hours

[17:24] Sign

Appointments Accepted

Until Noon

[17:24] Sign

Afternoon Appointments

From 14:00

[17:25] Conan

Even if his appointments ran over,
he'd be done by 1PM at the latest,

[17:30] Conan

and then eat lunch at home.

[17:33] Conan

Kanieda-san would sneak into his home and kill him using that rope.

[17:38] Conan

That was the plan, wasn't it?

[17:41] Haibara

If the dentist didn't show up after 2PM when his afternoon appointments started,

[17:45] Haibara

naturally someone would go check on him and discover the body.

[17:49] Conan

Since he clearly would've been killed during his lunch between 1PM to 2PM,

[17:54] Conan

you just needed to fabricate an alibi for that one hour period.

[17:58] Conan

Meanwhile, you witnessed an old woman being pushed down some steps in Beika City.

[18:04] Conan

But you couldn't testify.

[18:07] Conan

If you came forward as a witness, the police would ask for your identity.

[18:11] Conan

Even if you wanted to claim to be Kanieda Akira from Shikabone City,

[18:14] Conan

the name on your license would be different.

[18:16] Ayumi

So you said you didn't see anything and ran.

[18:19] Genta

You kept fabricating Kanieda-san's alibi.

[18:23] Mitsuhiko

And repeatedly took actions people around town would remember.

[18:30] Haibara

You hid the fact that you had an alibi because the alibi itself was part of an evil scheme.

[18:37] Chiba

You didn't want to be suspected of injuring Hachiya-san...

[18:41] Takagi

But you hid it, believing it was better

[18:44] Takagi

than the police discovering
you were helping a murderer.

[18:47] Conan

Your scheme was all for nothing, though.

[18:51] Conan

While heading to Saruwatari-sensei's house,

[18:54] Conan

Kanieda-san was involved in a traffic
accident and never managed to attack the dentist.

[18:59] Usui

What?

[18:59] Both

Huh?

[19:02] Usui

What?!

[19:04] Usui

You mean I could've said from the start that
I was fabricating an alibi in Beika City?

[19:11] Usui

Then what have I been doing
these past three days?

[19:14] Usui

Man, I'm beat.

[19:21] Megure

You fool!

[19:22] Megure

It was a coincidence that you didn't
become an accomplice to a murderer!

[19:30] Usui

You're absolutely correct.

SIGN Incoming Call

[19:34] Usui

My phone...

[19:35] Megure

You can answer it.

[19:36] Usui

Okay.

[19:41] Usui

Hello?

[19:43] Usui

Yes.

[19:45] Usui

Yes, sounds good.

[19:47] Usui

Yes. Bye.

[19:51] Usui

That was Kanieda-san.

[19:53] Usui

He's decided not to get revenge

[19:54] Usui

because he believes it was divine
punishment that he was struck by a car.

[19:59] Usui

I'm terribly sorry for the trouble I caused.

[20:04] Megure

In any case, we'll be
putting this on the record.

[20:07] Megure

Takagi and Chiba, go talk to Kanieda.

[20:11] Both

Yes, sir.

[20:12] Mitsuhiko

But now we're back to square
one with the injury case.

[20:16] Genta

Seriously. Who's the culprit in that case?

[20:20] Conan

If Usui-san's pen was at the crime scene
even though he never went to the park,

[20:24] Conan

then the culprit must've put it there.

[20:27] Conan

And the only person who had the
opportunity to do that was...

[20:30] Chiba

Could it be?

[20:31] Takagi

The woman who found the body.

[20:33] Megure

It was her?

[20:35] Sueko

I got the idea when I saw that Usui guy
arguing with Hachiya a few days ago.

[20:41] Sueko

I could get back at Hachiya
and frame him for it.

[20:46] Sueko

I picked up the ball point pen he
dropped then and used it yesterday.

[20:51] Sueko

Even if Usui had an alibi,

[20:53] Sueko

I figured you guys would
do something about it.

[20:58] Sueko

"He must've employed some kind of clever trick."

[21:00] Sueko

That's what you thought, right?

[21:07] Megure

I feel dizzy...
